# **ST MARGARET'S STATISTICS 2022**

## Notes for 2022

The figures above show the actual numbers in church. In 2020 and 2021, worship was restricted by the Covid lockdowns. An adjustment can be made by averaging up the figures, which then give a rough idea as to what might have happened without the Covid closures (averaged figures in italics):

It will be seen that the communicant figures show a modest but steady increase. The attendance figures reflect the closure of Wynstones School and are also affected by the number of baptisms, weddings and funerals. The reduced numbers coming to Family Praise since Covid are an additional factor.

# VICAR'S REPORT

# "You are the body of Christ, and each one of you is a part of it." 1 Corinthians 12.27

As we reflect on the life of our benefice in 2022, there is so much to thank God and one another for. I will be using the pronoun 'we' repeatedly in this report as it involves everyone across our Christian community. St Paul wrote to the Church in Corinth in the 1<sup>st</sup> Century, 'you are the body of Christ, and each one of you is a part of it' and this is as true today as it was then. We journey together, encouraging and supporting one another within the love and hope of Jesus. We are united through baptism and are all called to play our part in the mission and ministry of God. This might sound grand, but simply speaking it means we live our lives in the love and hope of Jesus – our lives are shaped by this love and hope; the light of Jesus makes a difference to how we live.

As Christians, we take seriously Jesus' commandment to us to love one another as he loved us (John 13) no matter how challenging this may be at times. St Paul goes on to talk about the nature of love in his letter (1 Corinthians 13) – the passage often read at weddings and funerals. He describes love as patient and kind, as believing all things, bearing all things. I see and experience this love across our benefice and thank each and every one of you for it. We have many different personalities, ideas and ways of being across our benefice AND we are united in the love and hope of Jesus. The difference and diversity across our benefice are a cause of celebration, as is the uniqueness of our two church buildings giving us such a wonderful opportunity to reflect the diversity and unity found in the body of Christ.

It is impossible to mention every way in which we have been able to reflect the love and hope of Jesus Christ during 2022 in this short report, but here are a few of the highlights...

# Open Afternoon at St George's 23rd April

This marked the start of our celebrations of 80 years of a church presence on the site. We displayed photos through the ages in church, served refreshments and free ice cream, and offered outdoor games for the children. The afternoon was well attended by members of the local community and many memories were shared.

## Film and faith discussion groups – Lent, September and Advent

The new film and faith discussion times have been a joy and a delight, with much support and engagement. We used the following films: The Kings' Speech, The Theory of Everything, and Miracle of 34<sup>th</sup> Street, with accompanying discussion material.

# Social events and Let us Entertain You

This year saw the welcome return of social events in the benefice, such as karaoke, a quiz evening and a beetle drive. We also enjoyed Let Us Entertain You in March and December, when we were surprised and amused by the range of talent on display!

## Fun and Free Tuesdays from May onwards.

Following a very fruitful 'open conversation' about our outreach and engagement with children and families we began to trial 'Fun and Free' on a Tuesday. Offering free ice lollies and outdoor games for an hour after school initially. During the Summer holidays, we extended this to three hours with lunch and indoor art/craft activities. The positive feedback from families led us to trial a new time from September of 1.30pm to 4.30pm, with the first half aimed at toddlers and pre-school and the latter aimed at school aged children. By the end of December, we had 12 toddlers registered and 50 school aged children.

## Queen Elizabeth II Platinum Jubilee Celebrations in May

It was wonderful to join with our friends from across the Church in Tuffley for a picnic in Randwick Park to celebrate the Platinum Jubilee. We paid tribute to the Queen's faithful, dedicated service to God and the country in special services at this time too. It was then bittersweet later in the year to hold special services to remember our beloved Queen before God, following her death on 8<sup>th</sup> September.

## Hosting of the Diocesan Visitation service and Deanery Synod Eucharist - June

June saw over 200 in the church at St George's, as churchwardens and their supporters from across the diocese queued to get into church, to be sworn into office by the Archdeacons! Later in the month, we also hosted the Deanery Synod Eucharist and social.

## Teddy-bear zip-wire & picnic at St Margaret's on 4<sup>th</sup> August.

Over 80 'teddy bears' (including pandas, monkeys, dragons etc) descended the zip wire during this wonderful event! All ages enjoyed their picnics and outdoor games in the glorious sunshine, and the ice cream van was much appreciated! It was such a joy to see so many from across our benefice and community gathered together for this fantastic afternoon.

# Heritage Open Days at St Margaret's 9/10<sup>th</sup> September

After much preparation work, the church building was open from 11.00am to 3.00pm for people to explore, along with the flag room. Refreshments were served outside in a marquee. There were many visitors, especially on the Saturday, and a range of fascinating conversations were had about faith, the history of the church, and people's memories from years ago!

## Family Praise new time from September

A new time for Family Praise of 4.00pm on the Second Sunday of the month was launched with a view to attracting more families. There continues to be several very committed and engaged families at this creative and informal worship service.

# Christmas Fayre celebrating 80 years of St George's – 13<sup>th</sup> December

St George's held a Christmas Fayre for the first time in 14 years! It was also another wonderful opportunity to celebrate 80 years of their being a church presence on the site, with the first hut being dedicated on 21<sup>st</sup> December 1942. The Charter Band played Christmas music in

the church, whilst people looked at photos through the ages and children decorated biscuits and visited Santa. The main hall was packed with stalls, and refreshments were served nonstop from the kitchen. The whole site was buzzing with people and a joyful Christmas atmosphere!

## Messy Christingle and Nativity Fun at St George's - December

Saturdays in December were busy! On the two Saturdays following the Christmas Fayre, we welcomed children and families into church for Messy Christingle, and then for Nativity Fun. Both mornings consisted of art/craft activities, including edible ones, and concluded with a Christingle service and a scratch Nativity respectively!

# Schools' engagement, including Explore events, Christingle and Christmas services

It was wonderful to be able to go into schools again to lead assemblies, and to welcome the schools back into church again after two years of not being able to do so. In January, David Crunkhurn began his role as Community Pastor at Grange Baptist, after many years of being an elder at the church and Headteacher at a CofE Primary School. It has been such a blessing to have David's many gifts and talents, experience and enthusiasm shared across the CiT. David led us in offering Explore Easter and Explore Christmas in 2022 and it was a great privilege to host this at St George's. This involved around 500 children and staff at Easter from Grange Primary and Harewood Junior, rising to 600 children at Christmas with the addition of Harewood Infant. We were also delighted to welcome Grange Primary into church for Christingle, and Harewood Junior for their Christmas service – when nearly every bit of floor space was occupied by a child!

## Church in Tuffley (CiT)

One of the huge highlights in the life of our benefice is sharing in worship, witness and social time with our friends across the Church in Tuffley (English Martyrs, Grange Baptist and St Barnabas). It has been a joy to continue to meet together monthly for Refresh, sharing in worship and Bible study (and cake), and for a monthly litter pick in our community. The legendary pancake party at English Martyrs was able to resume this year as was Holiday at Home (a day at the beach in EM Hall, with games, entertainment and food provided by people from across the CiT). We also spent a significant time together on Good Friday, joining together for Messy Easter at St Barnabas, Communion at Grange Baptist, a walk of witness in Tuffley, concluding at EM for the Passion of our Lord. As mentioned above, the CiT picnic to celebrate the Platinum Jubilee was also a fantastic time of celebration together.

## Welcomes and goodbyes

We were delighted to welcome Laine Lewis in September as 'Ordinand on Placement' as she embarked on ordination training through Trinity College, Bristol. Laine is studying on the Dispersed Learning Programme at Trinity, which involves a contextual placement of three days a week (including Sundays) alongside three days a week of study (and block study weeks at Bristol). In a few short months, Laine quickly became part of the family at St George's and St Margaret's. Her gifts and talents are much appreciated, especially in relation to leading worship, Fun and Free Tuesdays, Family Praise, and the Saturday family events. She has also established a weekly lunchtime club at Grange Primary and explored strengthening links with Podsmead Big Local. Hopefully Laine will be with us till May 2024.

We must also pay tribute to Michael Mumby, who sadly died on 27<sup>th</sup> December 2022. Mike gave so much to the life of our benefice over the years, including serving as Churchwarden at St Margaret's, Chair of St George's Centre Management Committee, Chair of St George's Entertainers, and being a leading light in many other ways. His strength of faith and his determined positivity were an inspiration to us all, as were his generosity, humour and character – he will be much missed. Our love and prayers remain with Laura, and all family.

# **ST GEORGE'S CHURCH SAFEGUARDING REPORT**

## 1 Introduction

Safeguarding is the responsibility of us all, as individuals, and of society as a whole. There are a range of harms and risks, a range of individuals who are at risk, or who have vulnerability factors and a range of individuals, including organisations who may cause harm to an individual or to vulnerable groups.

Safeguarding is about promoting wellbeing, preventing harm and responding to needs and concerns of harm. It is about preventing opportunities for harm to occur, particularly, where in connection with people living with vulnerability factors or in relation to children and young people.

It is part of assuring positions of trust and promotes that the balance of power is directed towards those who are most vulnerable, those most in need and who may be perceived as having, or who feel that they may have, little power. For those in a position of trust safeguarding places a duty to act, and to be held accountable, both for acts and omissions.

Safeguarding is defined within European legislation and within UK legislation, both for adults and for children. Human rights apply equality to all human beings. Safeguarding is a range of activities that uphold human rights. It is about providing opportunities which promote and strengthen wellbeing. It is about supporting and enabling people to access their rights and choices and where possible, for

that person, to make their own decisions. It ensures rights are upheld and promoted, particularly where a person is not able to do this for themselves.

Within the context of our church family, safeguarding principles and legislation equally apply. There is a window of opportunity, which may not be available within any other setting, both to safeguard or to harm.

Safeguarding in its true sense is a demonstration of faith and an opportunity to serve our community.

It is part of the role of a Parochial Church Council (PCC) to give assurance regarding all aspects of safeguarding in relation to all Church activities involving children, young people and adults.

"Safeguarding is at the heart of our Christian faith. We are all made unique and in the image of God. Jesus came that we might have life and have it in abundance (John 10.10). 'Safeguarding' means the action the Church takes to promote a safer culture in all our churches. In order to achieve this, we need to do a lot of hard work. We will promote the welfare of children, young people and adults. We will work to prevent abuse from occurring. We will seek to protect those who are at risk of being abused and respond well to those who have been abused. We will take care to identify where a person may present a risk to others and offer support to them whilst taking steps to mitigate such risks."

Promoting a Safer Church, The Church of England's Safeguarding Policy Statement 2018

"The Church of England is called to share the good news of God's salvation through Jesus Christ. The life of our communities and institutions is integral to how we address this task. The good news speaks of welcome for all, with a particular regard for those who are most vulnerable, into a community where the value and dignity of every human being is affirmed and those in positions of responsibility and authority are truly trustworthy. Being faithful to our call to share the gospel therefore compels us to take with the utmost seriousness the challenge of preventing abuse from happening and responding well where it has." # 2. St George's Church Safeguarding Activity Report and Highlights

- **2.1.** The Vicar of St George's Church and St Margaret's Church, and joint PCC members are committed to inclusion, to Safeguarding and to demonstrating this in action.
- **2.2** Each PCC Safeguarding Report, to each PCC meeting contains a section which highlights a different area of safeguarding. This has included a safeguarding overview, a spotlight on Domestic abuse and an overview of Safeguarding Children.
  - **2.3** In July 2022 a St George's Church Parish Safeguarding Officer (PSO) Volunteer, was recruited into role. This is on a trial basis and is reviewed each 6 months. Although committed to this

role, due to current working life priorities, it is challenging for St George's Church PSO Volunteer to dedicate the amount of time, as would be wished by St George's Church PSO Volunteer, to support this volunteer role. Next review is scheduled for end June 2023.

- **2.4.** DBS checking and DSB recording is not undertaken by St George's Church PSO Volunteer This is to be discussed as part of the planned role review at end of June 2023.
- **2.5.** St George's Church and St Margaret's Church Safeguarding Policies were reviewed, updated and approved at the September 2022 PCC meeting. St George's Church Safeguarding Policy is accessed from St George's Church Internet web page. The Safeguarding contact numbers for St George's Church, including contact numbers in hours and out of hours for Diocese of Gloucester Safeguarding Team is displayed within the Church and has kindly been added to "Signpost".
- **2.6.** Safeguarding assurance and accountability are key responsibilities of a PCC. The Parish Safeguarding Dashboard provides a structure to support this. The Dashboard is described by Gloucestershire Diocese Safeguarding Team as, "an audit tool", "a benchmark guide" and a means to assist a PCC in understanding and achieving all the key components, required to be in place, to demonstrate and evidence safeguarding assurance, both in practice and in action.

There are 3 levels to be achieved, with each level required to be completed ahead of progressing to the next level.

- Level 1 Safer Foundations
- Level 2 Safer Activities
- Level 3 Safer Practices

St George's Church Parish Safeguarding Dashboard is being progressed at level 1.

**2.7** By law any person, in any "position of trust" whether in a paid role or a volunteer role, must complete the appropriate level of safeguarding training, as relevant to their role and for this training to be updated regularly. A register must be maintained to evidence training compliance and that this is in date.

Gloucestershire Diocese Safeguarding training covers the latest range of safeguarding topics. This provides the necessary skills, awareness, guidance, support and equips us with the means to help to keep each other and our congregation safer. In addition, it helps to keep ourselves safe within our Church roles. Safeguarding Training assurance is a priority action for our PCC, as part of our level 1 action plan. With the agreement of Gloucestershire Diocese Safeguarding training Team, 3 group safeguarding training sessions were held during November and December 2022 for St George's Church and St Margaret's Church PCC, Church Volunteers and congregations. This followed the on-line

e-learning packages with opportunity for discussion and with support available for those attending.

- 22 members completed Safeguarding Awareness Training
- 15 members completed Raising Awareness of Domestic Abuse Training

St George's Church Safeguarding training compliance assurance register is currently being updated. This is presented at each PCC meeting.

**2.8** There is a need for Church activity leaders, to complete a risk assessment for any, and all activities which involves children, young people, or adults with vulnerability factors and to evidence safeguarding prevention and response actions, as part of their risk assessment. This is in addition to any Health and Safety risk assessment. This follows the Church of England, "Model Activity Risk Assessment Template".

There is a requirement for PCC to approve each risk assessment, and to maintain a centralised record of each up to date, approved, activity specific risk assessment.

There are different standards and risk assessments requirements, for both health and safety and safeguarding, relating to activities where a child or young person is accompanied by a parent, carer or guardian, during a Church activity, and where not accompanied. This also relates to any adult who has care and/or support needs.

A one-page overview guide, to support Church activity leaders planning process, for activities where a child or young person is accompanied by a parent, carer or guardian was drafted in November 2022.

There is a need for all Church activity leaders, and PCC members to ensure that all activities comply with the requirements as defined within the Church of England, "Safer Environments and Activities" document (2019).

- **2.9** Between March and June 2023, it is proposed that a review of Church of England requirements relating to Safer Recruitment be undertaken by St Georges Church PSO Volunteer and presented for review by PCC members.
- **2.10** Following Diocese of Gloucester Safeguarding Team guidance a confidential record is maintained, and securely stored for any Safeguarding concern or allegation raised.

- **2.11** An annual safeguarding awareness calendar, linked to local and national safeguarding campaigns is being explored. St George's Church PSO Volunteer to seek guidance from Gloucestershire Diocese Safeguarding Team and PCC in support of this.
- **2.12** To implement, at St George's Church, 2 dedicated safeguarding /wellbeing information leaflet racks and to establish a dedicated safeguarding /wellbeing information notice board display. St George's Church PSO Volunteer to link with appropriate local charity and statutory organisation, local Police Community Officers and Gloucestershire Fire and Rescue Service, Home Safe and Well Team.

# 3. Thank you

St George's Church PSO Volunteer is grateful for the support of our Vicar, of St Margaret's Church Safeguarding PSO, of St George's Church congregation, of PCC members and of Gloucestershire Diocese Safeguarding Team.

Gloucestershire Diocese Safeguarding Team have also 'buddied' St George's Church PSO Volunteer with the PSO Volunteer from St Lawrence's Church, Gloucester, as part of St George's Church PSO Volunteer 's role development plan.

# WHADDON, ST MARGARET OF SCOTLAND CHURCHWARDENS' REPORT

In the last two years, we had to report lengthy periods of "virtual" worship, the church being closed due to Covid. Mercifully that has not been the case during 2022, although we are always watchful for any resurgence in the virus. 2022 has been a welcome year of parish life and worship returning to something like pre Covid conditions. We can look back on some interesting initiatives, especially the Teddy Bears' Picnic in August and the Open Days in September.

# The TBP

The teddy bears picnic was an exercise in outreach to our local families, in the hope that people would come and see the church and churchyard, and have a fun experience. The centrepiece was a zip wire for teddies from the top of the tower. It was great fun, but hard work! An endless stream of teds made the descent and received certificates. The sun smiled on us, and a good time was had by all with games, refreshments and music.

## **Open Days**

The idea of a proper Open Day came from our PCC secretary, Georgina Wood. Why not combine the opening of the church for the GHCT Ride+Stride event with the Heritage Open Days initiative? Thanks to much planning, publicity and hard work, it was a very worthwhile event, and one which we intend to repeat and develop in future. Visitors could go up the first stage at the tower and see the flags and ancient graffiti, and peer into the nave roof space. There was plenty to see inside the church as well, and refreshments in a marquee.

We have also experimented with a regular weekly Open Church session, on Thursdays, but this did not attract significant support. We have however invested in a notice board saying CHURCH OPEN in large letters. This can be put out whenever the church is going to be open for any length of time, so churchyard users call in if they wish.

# Advent, Christmas and Epiphany

Our Darkness to Light Advent service was an exciting and moving introduction to the season. Sadly, our planned Family Praise Christingle was cancelled due to snow, but did take place in January. Likewise, the first of our candlelit carol services also had to be cancelled, but the second one was well attended.

## Family Praise

As we reported last year, numbers at Family Praise were badly affected by Covid and are still at a lowish ebb. What we have done is to move the service to the second Sunday at 4.00pm. This is partly because so many families have other activities on a Sunday morning. But it also means that our vicar can now take part, whereas the old time of 10.30am clashed with the main service at St George's.

## Care of the Building and its contents

There is not a lot to report on the fabric. The quinquennial inspection was held in the autumn. The state of the porch is still giving cause for concern, and we hope that progress, will now be made with a scheme of reinforcement. It was also noted that two of the merlons (or battlements) on the tower need to be refixed.

## Churchyard

2022 was a year of change in the churchyard, as we experimented with a different style of management. Short grass is not helpful to wildlife, and keeping it short comes at considerable cost of labour, petrol and noise.

We have been following advice from the Gloucestershire Wildlife Trust and from the Diocese, and are now focusing mostly on the area at the South end of the churchyard, furthest from the church. This produced a remarkable display of wildflowers in summer 2022, including two types of orchid, and the insect life is also very evident. And that was just the first summer of allowing the grass to grow. Inevitably opinions on our initiative have been mixed: many prefer the closer-cut style, even though that is itself a fairly recent tradition. We believe there is room for a compromise which will benefit nature and yet leave the more-visited areas of the churchyard much as people have come to expect.

# Neighbourhood

Efforts to reopen Wynstones school have sadly come to nothing, and the site is being marketed. In all likelihood it will become a housing estate, with anything up to 50 homes. It would be good to have more families living within walking distance of the church, but it will in all likelihood mean that the present car park for Wynstones will be lost in the process. This could have serious consequences for any special services at St Margaret's.

We have also been following the complex planning politics in relation to the Whaddon Fields proposal. This could create a new neighbourhood of more than 3000 houses on the area to the south of the church. Clearly there are major concerns about the ability of the local infrastructure to accept such an influx.

Thanks very largely to Pete and Lorraine Best, 170 welcome packs have been delivered in person to newly arrived residents, mostly on the Yew Tree Gardens development. It is good to report that some of these packs have borne fruit, in the form of people who have been coming, for example, to Fun and Free Tuesday at St George's or to the TBP at St Margaret's.

## Our thanks

We are so grateful to Rachel and to Paul for their Christian witness and companionship, and to our faithful congregation, and to our wider network of friends. We are indeed very greatly blessed, at St Margaret's and indeed in the benefice as a whole.

# **ST GEORGE'S FINANCES IN 2022**

A year of moving more towards 'normal' in financial terms, but again with a few added twists! The main headlines are: -

1. Total funds available to the PCC to spend as it decides (Unrestricted funds) reduced by £1,700.

2. The Church Centre showed a surplus of just under £700 for the year.

3. Monies available for specific purposes (Restricted funds) reduced by £1,700 during the year.

The outcome for Unrestricted funds was significantly better than originally projected, through a combination of increased giving and lower than anticipated expenditure.

The main themes from the Accounts which tell the story of the year are: -

- 1. Unrestricted Funds (to be used for the general objectives of the PCC)
- 1.1 General fund (day to day routine purposes)
- (a) Total payments were nearly £3,400 more than receipts (hence a deficit or loss).
- (b) Regular giving was up by £3,200 on 2021, reversing the reductions of recent years.
- (c) Fees income was nearly double that of 2021.
- (d) The contribution to Parish share increased by just over £2,000 as agreed.
- (e) The most significant increase in expenditure was in energy with both a usage and price increase. Usage was still lower than anticipated owing to mild weather and the gradual increase in use of the buildings following the pandemic.
- (f) Service costs continue to reflect the absence of a paid Music Leader.
- (g) Administrative expenses remain higher than in pre pandemic times with the Church Centre unable to pick up a share as a result of the reduced Centre activity and rental receipts.
- 1.2 Designated Funds (earmarked by the PCC for specific purposes e.g., Church Centre trading or to mark individual legacies)
- (a) A legacy of £1,000 was received from the estate of Margaret Rowell.
- (b) Receipts from user rentals for the Church Centre recovered significantly to £10,600 but still lower than pre pandemic levels compared of over £13,500.
- (c) Running expenses for the Church Centre increased by nearly 50% compared with 2021 and exceeded pre pandemic levels.
- 2. Restricted Funds (money given or raised for specific purposes)
- 2.1 A payment of £9,500 was made to pay off the remaining balance of the Diocesan loan used for the purchase of the Solar Panels and associated equipment at St George's. This was financed by an incredibly generous response to an appeal for which grateful thanks are due to those who contributed in any way.

Prospects for 2023 remain, as always, challenging.

Energy costs, pay and other inflationary pressures remain significant.

The increase in regular giving and the opportunity afforded by paying off the Diocesan loan early, however, give great cause for optimism.

The Deanery and Diocese continue to support us as we wrestle with the financial challenges, along with many other church communities. The seeds of regrowth following the pandemic are starting to shoot. We all need to pray that they may be nurtured and grow, this spring and throughout the year!

Further detail is contained within the Accounts and the explanatory notes. They tell one part of our story, and it is important that the story is clear. If you have any questions, please ask, you may be helping others to understand!

#### Notes

#### 1 Basis of Accounting

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.

#### 2 Accounting Policies

The financial statements include monetary transactions, assets and liabilities for which the PCC can be held responsible. They do not include the accounts of other Church groups that owe an affiliation to another body (namely Mothers' Union, Scouts etc.), nor those that are informal gatherings of Church members or other users of the Church Hall (e.g. Day Centre etc.)

Restricted funds must be used for the purpose for which the money was given or donated. Unrestricted funds represent money that can be used for the general charitable purposes of the PCC; amounts that have been earmarked for specific purposes are called designated funds, which nevertheless remain unrestricted.

The description, type and balance of each fund are given in note 19 below.

#### 3 Income tax recovered

Gift aid claims relating to giving via the Parish Giving Scheme are included up to December 2022. Other Gift Aid claims for the period to December 2021 are included.

The Wallace Hutchins Legacy, the Evelyn Chaloner Legacy, the Olive Collier Legacy, the Eva Spary Legacy and the Margaret Rowell Legacy have no specific restrictions and their use is at the PCC discretion.

The Pioneer Discretionary fund was set aside by the PCC as a contribution to the work of the Pioneer project. The Vestry fund was formed to buy chairs for the Vestry.

The Church Fabric Fund arises out of various donations for that purpose.

The Choir Fund was formed to provide resources for the Singing Group.

The Flower Fund was formed by the transfer from an independently held fund in 2003. The Vicar's Discretionary Fund was formed from specific donations.

The Curate's Discretionary Fund was formed from specific donations.

The Zac Evans Fund was formed from a one-off donation from an external fund to finance the creation of a garden

The Pioneer Fund is formed from donations for a project initially to fund a Pioneer post.

The Church Centre Fund is the trading account of the Church Centre

The Fun & Free Fund was formed from donations towards Children's work centred on Fun & Free Tuesdays

The Solar Panel fund was formed from donations to pay off the remaining Diocesan loan for solar energy generation equipme

#### 20 Debtors and Trade Creditors

Income tax claims of ca £4300 are due in respect of the period January-December 2022. The Discretionary fund trade creditors relates to tax and national insurance due to HMRC for the period October-December 2022 (payable in January 2023).

#### 21 DBF Loan

A DBF loan of just over £43,000 was taken out in December 2011 to finance the installation of PV panels on the Church roof. The loan is for a maximum of 25 years and is repaid via the income from the feed-in tariff from the electricity produced. The scheme is administered centrally by the DBF. An appeal was launched during 2022 for funds to pay off the outstanding loan 2022 2024

# **ST MARGARET'S FINANCES IN 2022**

# Overview

The main headlines are: -

- 1. Total funds available to the PCC to spend as it decides (Unrestricted funds) increased by £1,000 during the year; (compared to a £2,200 increase in 2021)
- 2. Planned giving increased by over 12%, plate giving almost doubled, offset by a sharp reduction in other donations.
- 3. The introduction of the Parish Giving scheme during the year ensures the majority of Gift Aid is now collected centrally and passed on monthly to the PCC.
- 4. Fees receipts remained at the same level as in 2021.
- 5. The Parish share contribution increased by £1,000 as planned.
- 6. Churchyard maintenance costs increased with the change in contractor and the project to introduce more environmentally friendly management of some areas.
- 7. There was no movement in restricted funds.

#### Notes

#### 1 Basis of Accounting

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.

#### 2 Accounting Policies

The financial statements include monetary transactions, assets and liabilities for which the PCC can be held responsible. They do not include the accounts of other Church groups that owe an affiliation to another body (namely Mothers' Union, Scouts etc.), nor those that are informal gatherings of Church members.

Restricted funds must be used for the purpose for which the money was given or donated. Unrestricted funds represent money that can be used for the general charitable purposes of the PCC; amounts that have been earmarked for specific purposes are called designated funds, which nevertheless remain unrestricted.

The description, type and balance of each fund are given in note 14 below.

#### 3 Income tax recovered

Gift aid claims relating to giving via the Parish Giving Scheme are included up to December 2022. Other Gift Aid claims for the period to December 2021 are included.
